# Terms and Conditions

## Eligibility Guidelines

1. The applicant applying for the rebate must be a water service customer of the City of Folsom, City of Sacramento, City of Placerville (administered by EID), El Dorado Irrigation District, Orange Vale Water Company or Sacramento Suburban Water District and the site where the equipment is to be installed must receive water service from that provider.
2. The site must currently be metered and have a minimum of 12 months of metered usage data.
3. Rebates are only available to improve existing in-ground irrigation systems and/or automatic timers. New irrigation system installations are not eligible.
4. The maximum rebate for improvement of irrigation system efficiency is the cost up to \$450.00 per customer. Labor and installation costs for irrigation efficiency improvements are eligible for a rebate. Please see #7 below for requirements.
5. The maximum rebate for the purchase of a SWAT-tested “Smart” (i.e., weather-based) irrigation controller is the purchase cost of the controller and signal service for a maximum of two years, if needed up to \$400.00 per retrofit. The Smart controller must be on the SWAT-tested list, which can be found at [www.irrigation.org/swat/](http://www.irrigation.org/swat/)
6. Signal service only on an existing Smart irrigation controller is not eligible for a rebate. If a signal based controller is chosen, the applicant agrees to maintain signal service at his/her own expense for a minimum of 5 years. Such commitment will be in addition to the time period covered by the rebate.
7. The maximum rebate for professional installation of a SWAT-tested Smart controller and irrigation efficiency improvements is \$150.00. The installation must be performed by a licensed California landscape contractor C-27 or irrigation specialty contractor C-61 / D-12 and/or be certified by the Irrigation Association as a Certified Landscape Irrigation Auditor. Qualified installers may be found on Regional Water Authority’s website at [www.rwah2o.org](http://www.rwah2o.org) and

include the following lists: Green Gardener and RWA Preferred Smart Controller Installers.

8. Any project(s) started before the Pre-Qualification Evaluation is performed are not eligible for any portion of these rebates.
9. All applications for rebates under the RWA Smart Irrigation Rebate Program must be submitted by no later than December 31, 2012.

## Instructions

1. The applicant should contact their participating water provider (see list below) to confirm the availability of rebate funds.
2. Submit a completed application to your water provider. Once the application has been received, a representative will contact you to schedule a Pre-Qualification Evaluation.
3. Once the evaluation has been completed, the water provider will inform the applicant of the equipment and materials that are approved for purchase and eligible for a rebate. Both the applicant and the water provider must sign and date the Pre- Qualification Evaluation form.
4. The purchase and installation of all approved equipment must be completed and a Post-Installation Inspection must be scheduled within 120 days from the date of the Pre-Qualification Evaluation.
5. After installation, the applicant must mail their signed and dated Pre-Qualification Evaluation form and original receipts to the water provider. Submission of the receipts and form are required to be eligible for a rebate under this program. If your contractor purchased the materials, please request a detailed invoice showing separate line-items for materials and labor.
6. Upon receipt of the documentation the water provider will contact the applicant to schedule their Post-Installation Inspection. Rebates will not be processed until an inspection has occurred.
7. Once approved a rebate will be issued by your water provider within 90 days from the date of the Post-Installation Inspection. Rebate checks will be made payable to the applicant and mailed to the address provided on the application. If your water provider is EID, rebates will be issued by a credit on your water service account.
